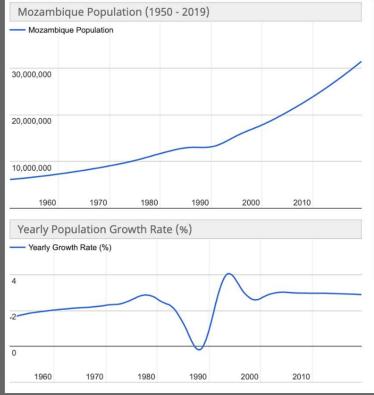
MOZAMBIQUE LOCATION VS POPULATION GROWTH

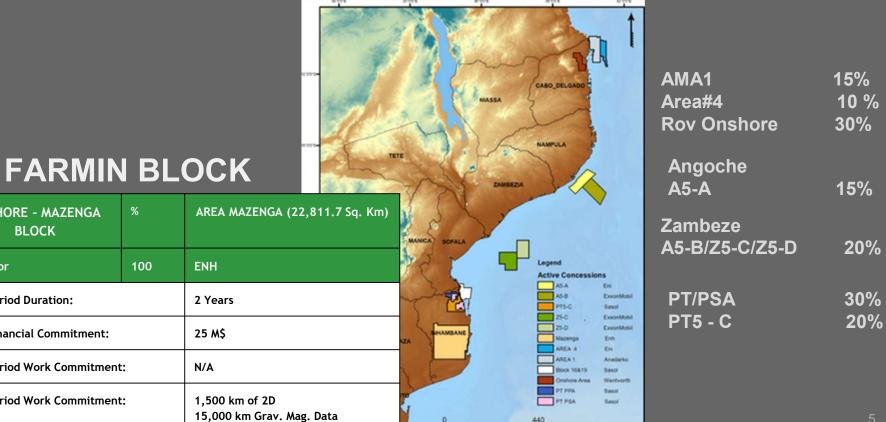

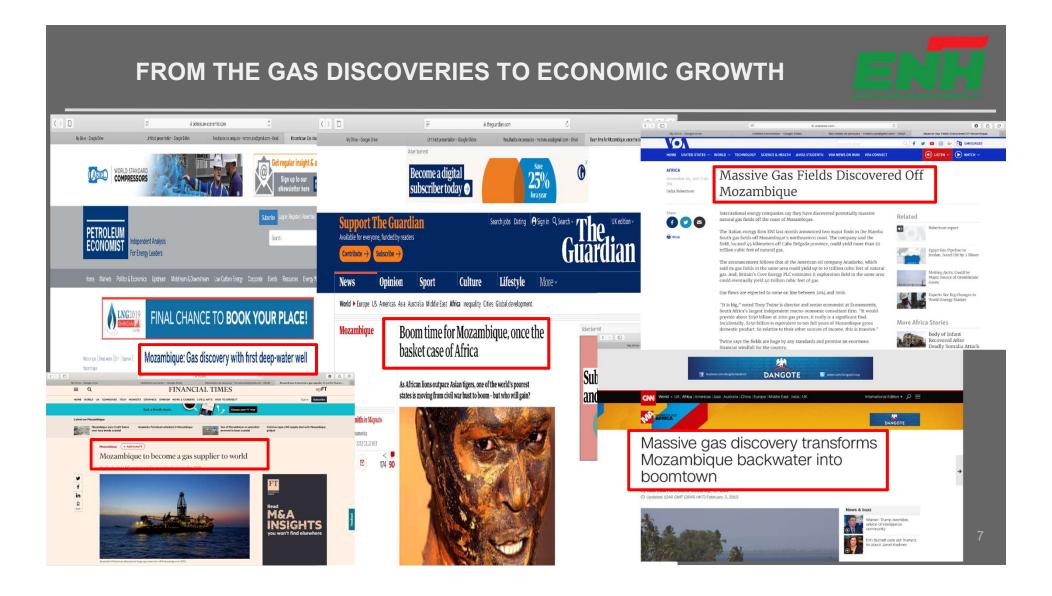












PROJECT STRUCTURE VS LIQUEFACTION PLANT
